The last year has been an incredibly challenging year for everyone in bowls.

Record rain fall affected green keepers preparing greens and Championships were disrupted on many occasions.

Eventually all Championships were completed, and all our winners played in State Finals which were held in the Illawarra area for the first time, due to a generous sponsorship from Wollongong City Council.

Unification has progressed slowly; clubs are coming to terms with what is required for the future.

The change to the playing season took some getting used to, but eventually everyone is coming to terms with that also.

Pennants were completed in both Men's and Open Gender formats, with 64 teams in Men's Pennants and 75 teams in the Open Gender.

Numbers are down in the Zone with the current figure around the 2100 mark.

Unfortunately, this is a trend across the state as most clubs are not attracting younger people into the game, except for barefoot bowls which is thriving. This says something about the lifestyle changes I believe.

While I do not like to single out clubs and individuals, we must acknowledge Warilla BC for winning 5 pennants, eclipsing Dapto Citizens who held the record with 4.

I would like to thank all clubs for their assistance during a trying season, particularly those that sponsored and hosted championships.

Personally, and on behalf of Zone 16, I would like to thank Mike Driscoll for all the coverage and support over the years.

Early 2021 we were told by Bowls NSW to cease Accreditation and Reaccreditation till further notice this was due to staff Shortage due Covid restriction, it was not till March 2022 we could proceed with Accreditation and Reaccreditation

The first Reaccreditation was held in MARCH 2022 at KIAMA BOWLING CLUB with about eight people to be examined, only one turned up this was very disappointing.

In the time from early 2022 to the start of 2023 we lost four P&A this left us with three this was due to Retirement and moving interstate we knew this was going make things harder than normal as P&A could not be passed till mid-2023, Also the Ladies were taken over by us this added to our numbers and to add to this BOWLS NSW asked to do Accreditation and Reaccreditation for BOWRAL and PICTON BOWLING CLUBS

During the time from late 2020 till 2022 BOWLS AUSTRALIA granted some people extension this ranged from 4 years to 1 year we are still finding persons with extension it would have been great to be notified

Now we are close to finishing Accreditation and Reaccreditation for 2023 our number are 197 Markers Measure and Umpires

Toward the end of the year persons who have not been Reaccredited will be removed from the list

A congratulations to Flynn Cooper, Jacob Aitken, and Travis Moran on selection to NSW under 18 squads.

Illawarra's top under 18s talent have made it back-to-back Metropolitan Shield triumphs with a near perfect display at St Johns Park Bowling Club.

The squad of 11 bowlers representing Dapto Citizens, Windang, Warilla, Corrimal, Windang, and Figtree Sports clubs won 11 of their 12 matches in a dominant performance against rivals from zones 5, 12, 13 and 15.

The victory highlights the quality of junior talent in Illawarra with success at under 18s level the first step on the pathway to making an Open Zone rep team soon along with recognition by state selectors at U18s and U25s level.

Our juniors competed in junior tournaments conduct in Zone 12 competing against outstanding competitors from other zones.

The junior south pacific carnival hosted by the Warilla Bowling club with attendance down from previous years, with Jacob Aitken winning the player of the carnival title.

The effort showed by the juniors was encouraging. A few things were noticed during competition that we may need to look at regarding training/coaching in the future.

A big thank you to all that helped throughout the year with our juniors, including other zone 16 officials, volunteers, family members and supporters.

Let's all hope for a better season during 2023-24 bowling season.

Thanks for the help throughout the year from Brian Huttly. Doing a great job.

Look forward to meeting, greeting, and encouraging any new juniors within the near future, let's hope all our current juniors continue to play this great game.

Zone 16 Junior Match Committee

Financial report for year ending 31 May 2023.

This is my fifth year as Zone 16 Treasurer, and it is with great pleasure that I advise the following financial status of Zone 16 Bowls Association Inc. for year ending 31 May 2023.

Zone 16 showed a small loss of \$8,787 for the 12-month period from 1 June 2022 to 31 May 2023.

Having stated this, all tournaments and activities were conducted throughout the year, except for the Night Fours.

Pennant accommodation assistance grants of \$5,500 were paid, Juniors expenses totalled \$8,000 approximately. Petrol / travel expenses for zone representatives totalled \$6,000 approximately, and zone representatives' accommodation totalled \$16,300 approx.

South Pacific Carnival income was \$22,560 and expenses were \$22,226 resulting in a small profit of \$334.

Many of our zone umpires were accredited and or re-accredited costing approx. \$5,230. Including supply of rule books.

Affiliation fees were dramatically reduced by 25% in accordance with BNSW Ltd guidelines.

Over many previous years the zone has accumulated investments with the Greater Bank in the amount of \$122,451, realising a small interest of \$1,040 this year.

I would like to give special thanks to all our sponsors who have again come to our assistance making many of our tournaments possible.

Overall, Zone 16 stands in a particularly solid financial position going forward into 2023 / 2024.

A special thankyou to all bowling clubs' financial staff for their prompt payments as and when requested.

1 Summary of Significant Accounting Policies

These financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Reform Act 2012. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of the financial statements.

Revenue and Other Income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the association and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

Sale of goods

Revenue from the sale of goods is recognised at the point of delivery as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement in those goods.

Interest revenue

Interest revenue is recognised using the effective interest rate method.

If the outcome cannot be reliably estimated then revenue is recognised to the extent of expenses recognised that are recoverable.

Revenue from training services is generally recognised once the training has been delivered.

Inventories

Inventories are measured at the lower of cost and net realisable value.

Property, Plant and Equipment (PPE)

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.



Report on the Financial Report

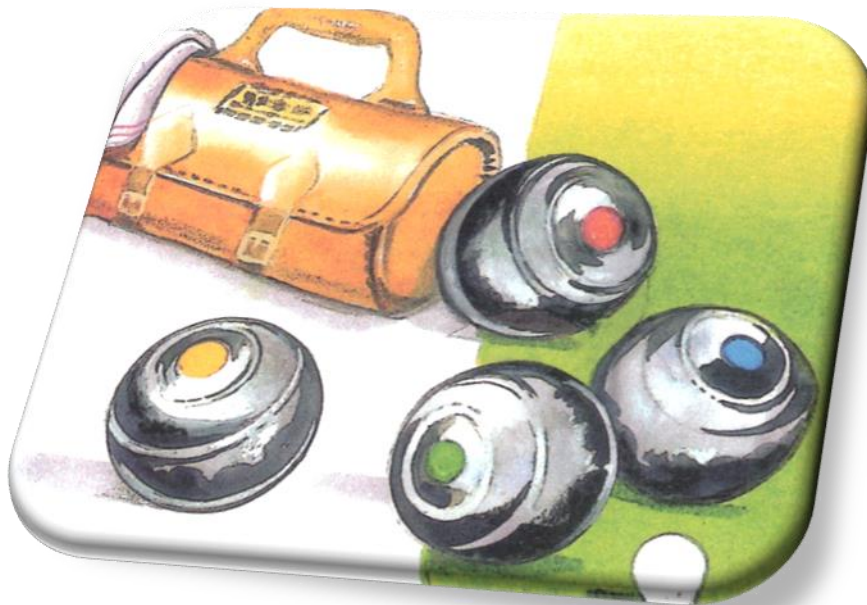
